Mr. Coronado asked Mr. Sutton who has the final say on what gets into the LCAP? At the last meeting, he said he had input and he doesn't see it reflected in the LCAP. Mrs. Davis said frequent feedback is included as well as prioritization.

Mr. Granda asked about the summer school in the LCAP. Mrs. Davis said we've heard clearly how we need to expand summer school. If a student gets a D, he or she can approach a counselor about replacing an elective with re-taking that class.

Mr. Coronado asked if a schedule can be provided on available tutoring. Mr. Sutton said Cabinet has discussed adding a tutoring schedule at all schools. Mr. Coronado said the \$18 million in reserve could be used to offer summer school for 7th or 8th graders. Mrs.

Davis said 7th and 8th grade students can take enrichment classes in CESA. Mr. Sutton and Mrs. Davis explained that we cannot mandate students to go to tutoring or to attend summer school. There's a phone dialer that goes out each month about counseling.

Mr. Coronado said many parents talk about CTE and wanted to know if he could tour the CTE classes? Mr. Birrell offered to give him a tour when students return.

Mr. Coronado asked if there's a way to add additional library hours with library aides, and also asked for studies about the efficacy of tutoring for the TK-3rd students. Mr. Sutton said he'd get that info to him.

Mr. Granda asked how many peer counselors do we have? Mrs. Davis said the peer counselors are students and she'd have to check to get more info about how many students are involved.

Mr. Coronado and Mr. Dawar asked how this works. Sonitrol is an alarm monitoring company so if we have a break-in, any noises are picked up and calls are placed to security and/or law enforcement for back-up. Mr. Granda said he uses this company for many of his buildings and it's a very solid company. Mrs. Cox asked why some schools have fire monitoring, but others don't--how are the schools selected? Mr. Porterfield said all schools have some type of fire monitoring. He said he'll look into which other company we use for the fire monitoring. Mr. Porterfield said we hope to consolidate down the road. Mr. Atkins asked how many campuses have video monitoring? Mr. Porterfield said all campuses have video monitoring, but it's not monitored by this alarm company. It's more of a deterrent than anything. Moved to consent.

K.12. INFORMATION REGARDING CAPACITY AT THE HIGH SCHOOL AND ROAMING TEACHERS (C. Granda)

Minutes:

Mr. Granda wants clarification about the portables and how they impact the roaming teachers. He asked about the portables we're adding and what percentage of those will offset the roaming. West campus will not receive more portables right now. Mrs. Davis said there are 11 roaming teachers at West. At East, we have 21 roaming teachers and the portables will decrease that to 13. Mr. Sutton said when we add portables, we'll be able to cluster the teachers more efficiently so they don't have to travel as far on campus. One teacher has to travel between the two campuses. On an odd day, a teacher may be at one location and on an even day, may be at the other campus. One remedy suggested by Mr. Kelejian is to hire one FTE which is feasible. Mrs. Cox said if our enrollment goes up, to add a teacher is a requirement. Mrs. Cox asked about the Hmong

and Punjabi teachers--will they have to roam? Mr. Kelejian said they'll be housed at East and the West students will have to travel. Mr. Granda asked about prep time clarification. Each day, high school teachers have 1 period of prep time and 3 classes to teach. Every teacher is entitled to prep time. The Department of Ed determines the square feet of housing students. Judee Martinez said the teachers who roam don't see an end in sight and have a difficult situation. She thinks this is setting up the teachers and students for failure.
