WHEREAS, the Central Unified School District (“District”) has experienced student growth at Roosevelt Elementary School.

WHEREAS, the (6) 24x40 modular buildings meet the District’s needs is available for lease from Mobile Modular Management Corporation; under the terms of a competitively bid cooperative (“piggyback”) purchase agreement between the vendor and the Pajaro Valley Unified School District of Santa Cruz County; and

WHEREAS, the cooperative purchase agreement permits multiple school districts to purchase modular buildings from the vendor without the necessity of each district separately letting bids for such buildings; and

WHEREAS, the piggyback purchase agreement permits. Multiple school districts to purchase modular buildings from the vendor without the necessity of each district separately letting bids for such modular building; and

WHEREAS, the District is authorized to make purchase under such piggyback purchase agreements pursuant to the provision of Public Contract Code section 20118, if the Board finds that is the District’s best interest to do so; and

WHEREAS, District staff recommends that the Board authorized the use of the piggyback purchase agreement for purchase of the (9) 24 x 40 modular buildings and find that it is in the District’s best interest to use such piggyback purchase agreement to do so.

NOW THEREFORE BE IT RESOLVED that the Board of Trustees of the Central Unified School District hereby finds, determines, and orders as follows:

1. The foregoing recitals are adopted as true and correct.
2. The Superintendent or Assistance Superintendent/Chief Business Officer are authorized to use the piggyback purchase agreement between Pajaro Valley Unified School District and Mobile Modular Management Corporation for the above references (6) 24 x 40 modular buildings, and the Board finds that it is in the District’s best interest to do so.

3. The District's Superintendent and its Assistant Superintendent and Chief Business Officer are authorized and directed to take such further actions as may be necessary or convenient to carry out said purchase and comply with all related grant requirements.
4. This Resolution shall take effect immediately upon its adoption.
