Mr. Hansen,

Thank you for allowing EagleShield Pest Control to submit this proposal for your comprehensive Integrated Pest Management (IPM) program (See page 4). As per our conversation, it is our desire to provide an IPM program to the list of addresses attached (See page 5). We will also provide treatment as needed for the following pests: ants, earwigs, spiders, cockroaches, bees/wasps, crickets, fleas, mice/rats, gophers and squirrels. Other problems that may occur, such as birds (entry point and basic exclusion only will be **included**), bats, bee hive removal, and nuisance wildlife, will require a bid to be approved prior to any other work being done.

Each monthly service at every site will include:

1. Inspection of all food areas.
2. Sanitation reports listing any findings and recommendations.
3. Monitoring of abnormal pest activity.
4. Communication with grounds department.
5. Trapping and exclusion when necessary.
6. Application of pesticides when needed.
7. A binder left on the premises which will include the appropriate documentation.

Monthly Fee: **\$145 per site (28) = \$4,060**

*Nuisance Wildlife Trapping: \$150 per trap set/\$50 per animal removed*

Initial Fee: **WAIVED** – (This would include treatment of all sites over summer break).

## **Method/Plan:**

Pests will be managed to:

- Reduce any potential human health hazard or to protect against a significant threat to public safety.
- Prevent loss or damage to school resources, structures or property.
- Prevent pests from spreading to the community or to plant and animal populations beyond the school site.
- Enhance the quality of life for students, staff and others.

The level of pest control and the method of pest management to be considered are as follows:

- Non-Chemical prevention of pest populations using methods such as sanitation, exclusion and cultural methods.
- Application of pesticides only “as needed” to correct verified problems.
- Selection of the least hazardous methods and materials that are effective for the control of targeted pests.
- Precision targeting of pesticides to areas not contacted or accessible to the children, faculty and staff.

We are also registered to administer Fumigation treatment to sites that have an ongoing issue with gophers and squirrels and will provide a Fumigation Management Plan to do so. We have been very effective with the FMP programs we currently have in place at our schools.
