**Agreement Between  
The English Learner Group  
and  
Central Unified School District, Fresno, CA**

This Agreement is made and entered into by the **Central Unified School District**, in Fresno, CA, hereinafter referred to as the **DISTRICT**, and **The English Learner Group, Inc.** hereinafter referred to as **The Consultant**.

THEREFORE, the DISTRICT AND CONSULTANT mutually agree as follows:

**1. Contract Terms and Conditions**

- A. The Term of Contract shall be from July 1, 2018 to June 30, 2019.
- B. The Contract Fee shall be a total of \$142,500 that includes ninety-five days of educational consulting services.
- C. The Contract Fee includes the following:
  - 1. **Forty-five (45) days** of on site principal coaching to support English Learner linguistic and academic performance. One three hour session each month for nine months (September 2017 through May 2018) for the following sites:
    - a. Central High School East
    - b. Central High School West
    - c. Glacier Point Middle School
    - d. El Capitan Middle School
    - e. Madison Elementary School
    - f. McKinley Elementary School
    - g. Roosevelt Elementary School
    - h. Steinbeck Elementary School
    - i. Teague Elementary School
    - j. Tilley Elementary School
  - 2. **Fifty (50) days** of in-classroom instructional coaching for teachers to support the implementation of the Central Unified core ELD Materials (K-12), and the Central Unified Secondary plan for Newcomers in the context of the Content Area classrooms.
    - a. Central East High School (one day per month)
    - b. Central West High School (one day per month)
    - c. Glacier Point Middle School (four days total)
    - d. El Capitan Middle School (4 days total)
    - e. Madison ES, McKinley ES, Roosevelt ES, Steinbeck ES, Teague ES, Tilley ES (4 days for each site)
- 3. Total number of consulting days for this contract is 95.
  - i. Total contract cost of \$142,500.
  - ii. Ten equal monthly payments of \$14,250 will be submitted by the first day of each month, beginning September 1, 2017, and concluding on June 1, 2018. Payment will be mailed to (or submitted electronically):

**2. In receiving services, the DISTRICT agrees to specific activities as outlined:**

- A. The DISTRICT will adhere to an agreed upon process and timeline of events for all selected activities.
- B. The District will provide data requested by *The English Learner Group, Inc.* team, for analysis.
- C. The District will administer or facilitate collection of outcome, process, and perception data, which may include teacher, student, and/or parent surveys, and collection of student work samples.
- D. The DISTRICT understands that every educational or instructional suggestion is advisory. There is no commitment from the district/school to comply to the advise.

**3. Cancellation of Agreement**

This agreement may be cancelled by *The English Learner Group* or the District if either party fails to provide agreed upon services, requested information or otherwise prevents *The English Learner Group* or the District from completing contracted work in accordance with state law. All notifications will be done in writing and sent by US Postal Service to the address for each entity listed below.

**4. Special Provisions**

- A. *The English Learner Group, Inc.* shall comply with all laws, rules and regulations applicable to such work.
- B. *The English Learner Group, Inc.* acknowledges that the services provided by its employees may involve limited contact with students and, as such, each member of the team will have background checks pursuant to the Education Code.
- C. Agreement may be amended by the mutual written consent of the parties hereto.
