PROPOSAL FOR PROFESSIONAL SERVICES March 12,2018

DARDEN ARCHITECTS, INC. will provide professional architectural services to CENTRAL UNIFIED SCHOOL DISTRICT for the development an exterior school color concept to be used during a District Exterior Painting Project at El Capitan Middle School. Summation of the scope of the project consist of the following:

SCOPE OF PROJECT: Currently the proposed scope is to be limited in order for the project to be considered as a Maintenance Project and therefore will not require DSA's review and approval. Any work that would be considered as an improvement project by DSA, such as floor and wall finish, casework, etc., is not part of the scope of services. It will be the responsibility of the District to determine if such work is desired and when the District will be performed such work. Therefore, the purpose of this proposal, the Scope of Services is limited to developing the following;

- 1. Develop exterior color scheme for the entire school campus.
- 2. Create a graphic identity utilizing a School Logo / Mascot design for three or four graphic signs.
- 3. Develop classroom Identifying replacement signage.
- 4. For the purpose of this proposal, it is the assumption that the current Order of Magnitude of the Opinion of Probable Construction Cost for the exterior painting and replacement signage is around \$350,000.00. This assumption is based on previous projects that included exterior painting and signage of similar scope.

SCOPE OF BASIC SERVICES: The extent of the basic services is based on the limited scope of the project. The Professional Basic Services that are required is anticipated to consist of preparing Project Documents consisting of the following:
