OBJECTIVE:

The Student will complete the courses listed above during the school year through Augustus Academy of Creative Arts & Technology. All course objectives will be consistent with the established Academic Content Standards of the State of California.

RESOURCES:

Augustus Academy of Creative Arts & Technology will provide a credentialed teacher for each subject area and instructional materials when applicable. It is the Student's responsibility to acquire a computer with internet access in order to obtain all of the digital materials. The school shall ensure the same access to all existing services and resources in the school in which the pupil is enrolled pursuant to the California Education Code Section 51748 (School districts and county offices of education shall not be eligible to receive apportionment for independent study attendance by any pupil who is not otherwise identified in the written records of the district or county board by grade level, program placement, and the school in which he or she is enrolled as is available to all other pupils in the school).

COURSE EVALUATION:

Student academic progress and specific methods of evaluation include quizzes, tests, written assignments, worksheets, participation, and other methods as outlined in the subject/course descriptions and course syllabi.

METHOD OF STUDY AND ATTENDANCE REQUIREMENTS:

- Students are required to log into and progress adequately through each of their courses.
- Students are expected to complete assignments according to the pacing guides provided in each course.
- Students are expected to attend meetings, classes and additional support on-site on Tuesdays, Wednesdays, Thursdays, and Fridays.
- Students are required to communicate weekly with their advisor and each of their assigned teachers.
- If a Student experiences difficulties or challenges in any of his or her courses it is his or her responsibility to email and/or call the teacher, advisor and/or counselor.
- It is the responsibility of each Student, despite any technical difficulty, to log into their courses and adhere to the attendance policy. If a Student encounters obstacles that hinder their ability to adhere to the attendance policy, the Student's advisor must be contacted immediately.
- Students are required to attend in person all state testing at a predetermined designated school location.
- Students and parents/guardians are required to notify the advisor within five (5) business days to update any changes to personal contact information (mailing address, phone number and/or email address).
- Students and parents/guardians acknowledge to abide by the policies and procedures contained in Augustus' Student/Parent Handbook and Board Policy Manual.

AGREEMENT:

We have read this agreement and hereby agree to all conditions. It is understood that failure to abide by this agreement will result in an intervention by a school administrator and may result in the Student being referred back to his or her school of residence. Independent Study is an optional educational alternative in which no pupil may be required to participate. Students of the independent study program who were previously provided with unconventional classroom instruction and were expelled (California Education Code Section 48915) or suspended (California Education Code Section 48917) are eligible for further educational instruction.
